Annual club membership is required to retain your voting rights and currently costs £30 a year. You can pay the £500 as a lump-sum, or if you wish, you can make interest-free payments by twelve monthly instalments - a first instalment of £41.74, followed by eleven equal instalments of £41.66. Your membership begins when you pay your first instalment.

A **£1,000** payment will give you one thousand community shares and ten years' club membership from the date of purchase. Annual club membership is required to retain your voting rights and currently costs £30 a year. You can pay the £1,000 as a lump-sum, or if you wish, you can make interest-free payments by twelve monthly instalments – a first instalment of £83.48, followed by eleven equal instalments of £83.32. Your membership begins when you pay your first instalment.

A **£3,000** payment will give you three thousand community shares and life club membership from the date of purchase and gives you your voting share for life and no requirement to pay an annual membership, which currently costs £30 a year. You can pay the £3,000 as a lump-sum, or if you wish, you can make interest-free payments by twelve equal monthly instalments of £250. Your membership begins when you pay your first instalment.
